Job Summary / Main Purpose:

- To ensure the safe transportation of all items to and from shops, customers' houses and other collection/delivery points.
- To ensure that the vehicle is kept clean and report any mechanical issues and in full compliance at all times with the necessary legal documentation such as MOT, Insurance and Vehicle Excise Duty
- To drive the vehicle only on Dorothy House Hospice Care business unless otherwise authorised.
- To carry out daily van checks and ensure these are recorded accurately and that any problems are reported.
- To deliver excellent standards of customer service when engaging with all our stakeholders and to be a brand ambassador of Dorothy house
- Communicate and update Customers effectively and professionally both face to face and over the phone.
- To support and assist the best use of space, high standards of cleanliness/tidiness in all areas of the warehouse, vans and other storage sites
- To respond promptly and efficiently to the implementation of new policies or changes in procedure.
- To have an overall awareness of the Retail Organisation and participate in education, training and development and attend meetings as required



- Driving licence to be reviewed on an annual basis. Dorothy House should be informed of any pending convictions within 24 hours or on your next working shift, whichever is sooner.
- Flexible work schedule, across 7 days as required to meet demand and business needs
- To ensure the gift aid scheme operates effectively by collecting donor details in line with GDPR guidelines.
- To support owns one overall wellbeing to deliver performance in a physically demanding role
- To fulfil mutually agreed additional duties as are deemed necessary for the needs of the business
